**1. SUMMARY OF THE NOTIFICATION**

Tessenderlo Group received a transparency notification on April 20, 2018, from Janus Henderson Group, indicating that it was holding 1,383,360 or 3.21% of the shares of the company as at April 13, 2018, and thus crossing the threshold of 3%.
